*Tropentag* is an annual international conference on research in food security, natural resource management and rural development.

Tropentag is jointly organised by the universities of Berlin, Bonn, Göttingen, Hohenheim and Kassel (Witzenhausen), ZALF e. V. Müncheberg, ETH Zurich (Switzerland), CULS Prague (Czechia), BOKU Vienna (Austria) and the Council for Tropical and Subtropical Research (ATSAF e. V.) - in cooperation with the GIZ Advisory Service on Agricultural Research for Development (BEAF).

It brings together scientists, students, graduates, development experts and funding organisations from several countries in central Europe and their various international partner institutions.

Tropentag is a development-oriented and interdisciplinary conference. It addresses issues of resource and environmental management, agricultural production, forestry, fisheries, food, nutrition and related sciences in the context of international rural development, sustainable resource use, hunger and poverty alleviation worldwide.

#### The 2015 conference theme:

# Management of Land Use Systems for Enhanced Food Security: Conflicts, Controversies and Resolutions

Food security has become a major worldwide concern and key policy issue. It will be increasingly challenging to feed the rapidly growing population in a declining area of arable and fertile land under unfavourable and unpredictable climatic conditions. Land has become a precious resource. A growing land use competition for the production of food, fodder & forage, biofuels or forestry goods is creating tensions and conflicts. Especially the poorest nations in tropical regions have the highest prevalence of malnutrition – caused by inconsistent food availability, accessibility, utilisation and stability. The mainly rain-fed, subsistence-oriented smallholder farming systems are extremely vulnerable to environmental stressors and often lack access to inputs and resources, institutional support and, ultimately, adaptive capacity. The highly complex state of vulnerability needs to be addressed encompassing economic and sociopolitical factors which play a pivotal role in ameliorating food insecurity. Thus, effective adaptation and intervention strategies need to pursue a holistic approach and an array of objectives, including social and economic viability, gender empowerment, improvement of infrastructure and market access as well as soil health, minimum use of scarce water and fossil energy or conservation of natural resources and biodiversity. The issue is marked by a high degree of complexity; interests of stakeholders collide, and strategic concepts diverge. Creating a sustainable roadmap for the future will be a challenging task for our global community. We invite you to discuss possible solutions in an effort to enhance food and nutritional security in the tropics.

#### Conference structure

Tropentag is organised into six parallel themes with four sessions held under each theme. We may widen the session number in case the need arises.

Each theme will be opened by an invited lecture, to be followed by four original papers.

During the guided poster sessions, every poster author will introduce her/his topic (3 minutes talk).

#### Submission procedure

The conference language is English. Please ensure that abstracts submitted are written in a high level of English poorly written abstracts will be excluded.

Abstracts of original research containing 250-350 words must be submitted using the online form at www.tropentag.de by May 1, 2015.

A panel of referees will decide which contributions to accept based on the abstracts. Whether a contribution is accepted as a poster or as an oral presentation is determined by the panel of referees.

A programme committee will allocate the accepted oral contributions to interdisciplinary sessions. Notifications of acceptance are sent on July 1, 2015. Contributors must confirm their participation by July 15, 2015 and pay their conference fee before August 1, 2015.

Poster contributions will be grouped into thematic clusters and addressed in guided poster sessions. All presented contributions will be contained in the Book of Abstracts. both in print and online. Authors of presented contributions are encouraged to submit a four-page version of their contribution by October 30, 2015, for online publication.

# Organise your own Workshop

You can either network targeting a specific topic (related to tropical agriculture), or you offer capacity building, task forces for projects and follow your own initiative. Workshops can take place before or after the conference. You need to describe the objective and topic of the workshop and send your application not later than July 31 to
