- Please always be aware of the correct format!

Citation of own Publications & References

Articles in a Journal

Example:

Scherbaum V, Purwestri RC, Stuetz W, Inayati DA, Suryantan J, Bloem MA, Biesalski HK (2015). Locally produced cereal/nut/legume-based biscuits. *Asia Pac J Clin Nutr* 24(1):152-61.

Structure:

Author`s last name – Blank character – Author`s first name(s) (abbreviated, without a dot) [Several authors separated by a comma and a blank character] – Year in brackets – Dot – Blank character – Title of the article – Dot (or e.g. question mark etc.) – Blank character – **Journal name (abbreviated)**, without any dots) – Blank character – Number of the journal (volume) followed by the number of the issue in brackets without a space – Colon (without a space) – Page numbers (without any spaces) – Dot

- Please indicate the **official abbreviation of the journal name** as given in **Pubmed** (<http://www.ncbi.nlm.nih.gov/pubmed/>). If there is no official abbreviation, please indicate the full name of the journal.

Citation of own Publications

Please note!

Your **own published journal articles** shall be split into **two lists**:

1. A list of articles published in **peer-reviewed journals** and
2. A list of articles published in **not peer-reviewed journals**.

Citation of own Publications & References

Books (published)

Example:

Schmidt F, Rosegrant MF (1960). How to succeed in food security. Second edition, Gustav-Angler-Verlag, Jena, Germany.

Structure:

Autor`s last name – Blank character – Author`s first name(s) (abbreviated, without a dot) [Several authors separated by a comma and a blank character] – Year in brackets – Dot – Blank character – Title of the book – Dot – Blank character – Number of the edition – Comma – Blank character – Name of the publishing company or organisation – Comma – Blank character – Location of the publishing company or organisation (city and country) [each information separated by a comma followed by a blank character] – Dot

Citation of own Publications & References

Chapters in a published Book

Example:

Egner F, Starmer C, Christiansen S (1980). The role of women in agriculture. In: Schmidt F, Rosegrant MF (Eds.). Food Security. Second edition, Gustav-Angler-Verlag, Jena, Germany, pp. 256-258.

Structure:

Autor`s last name – Blank character – Author`s first name(s) (abbreviated, without a dot) [Several authors separated by a comma and a blank character] – Year in brackets – Dot – Blank character – Title of the book chapter – Dot – Blank character – Word “In“ followed by a colon and a blank character – Editor`s last name – Blank character – Editor`s first name(s) (abbreviated, without a dot) [Several editors separated by a comma and a blank character] followed by a blank character and the word “Ed.” (if one editor) or “Eds.” (if two or several editors) in brackets – Dot – Blank character – Title of the book – Dot – Blank character – Number of the edition – Comma – Blank character – Name of the publishing company or organisation – Comma – Blank character – Location of the publishing company or organisation (city and country) [each information separated by a comma followed by a blank character] – Comma – Blank character – Page numbers (one page shall be abbreviated with “p.” and two or several pages with “pp.”, followed by a blank character) – Dot

Citation of own Publications & References

Conference/Congress Proceedings (published)

Example:

Lashkari-Bod A, Zebitz CPW (2014). Diversity and abundance of parasitoids in organic apple orchards in Baden-Württemberg [Congress contribution]. 16th International Conference on Organic Fruit-Growing, Eco-Fruit. Universität Hohenheim, Stuttgart, Germany, 17-19 Februar 2014. Proceedings of the 16th International Conference on Organic Fruit-Growing, pp. 195-198.

Structure:

Autor`s last name – Blank character - Author`s first name(s) (abbreviated, without a dot) [Several authors separated by a comma and a blank character] – Year in brackets – Dot – Blank character – Title of the congress/conference contribution followed by a blank character – **“Congress contribution”** or **“Conference contribution” in squared brackets** – Dot – Blank character – Title of the congress/conference – Dot – Blank character – Location (institution, city, country) [each information separated by a comma followed by a blank character] – Comma – Blank character – Date (day(s), month and year) – Dot – Blank character – Title of the proceedings – Comma – Blank character – Page numbers (one page shall be abbreviated with “p.” and two or several pages with “pp.”, followed by a blank character) – Dot

Citation of own Publications & References

Dissertations (PhD Theses)

Example:

Bati BM (2013). Climate change, cattle herd vulnerability and food insecurity: Adaptation through livestock diversification in the Borana pastoral system of Ethiopia [Dissertation]. Institute of Animal Production in the Tropics and Subtropics, University of Hohenheim, Stuttgart, Germany.

Structure:

Autor`s last name – Blank character – Author`s first name(s) (abbreviated, without a dot) – Blank character – Year in brackets – Dot – Blank character – Title of the dissertation followed by a blank character – **“Dissertation” in squared brackets** – Dot – Blank character – Institute/department of the high school – Comma – Blank character – Name of the high school – Location (city and country) [each information separated by a comma followed by a blank character] – Dot

Citation of own Publications & References

Further Citations – e.g. Abstracts in a Journal

Example:

Krummholz H, Joseph P (2005). Social issues on food security [Abstract]. Indian Pediatr 52(9):773-8.

Structure:

Autor`s last name – Blank character – Author`s first name(s) (abbreviated, without a dot) [Several authors separated by a comma and a blank character] – Year in brackets – Dot – Blank character – Title, e.g. of the abstract, followed by a blank character – **“Abstract” or another adequate word in squared brackets** – Dot – Blank character – **Journal name (abbreviated, without any dots)**, or another adequate information – Blank character – Number of the journal (volume) followed by the number of the issue in brackets and without a space, or another adequate information – Colon (without a space) – Page numbers (without any spaces), or another adequate information if applicable – Dot

- Please indicate the **official abbreviation of the journal name** as given in **Pubmed** (<http://www.ncbi.nlm.nih.gov/pubmed/>). If there is no official abbreviation, please indicate the full name of the journal.

Citation of your Participation with active Contribution

Participation in a Congress, Conference, Meeting etc.

...with active Contribution: Poster Presenters or Participants giving an Oral Presentation

Example:

Mounde L, Boh MY, Cotter M, Sauerborn J (2014). Potential of rhizobacteria for promotion of sorghum growth and suppression of Striga development [Poster]. Tropentag Conference 2014. Czech University of Life Sciences Prague, Czech Republic, 17-19 September 2014.

Structure:

Autor`s last name – Blank character – Author`s first name(s) (abbreviated, without a dot) [Several authors separated by a comma and a blank character] – Year in brackets – Dot – Blank character – Title of the poster/oral presentation followed by a blank character – **“Poster”** or **“Oral Presentation”** in **squared brackets** – Dot – Blank character – Title of the congress/conference – Dot – Blank character – Location (institution, city and country) [each information separated by a comma followed by a blank character] – Comma – Blank character – Date (day(s), month and year) – Dot

Citation of your Participation without active Contribution

Participation in a Congress, Conference, Meeting etc.

...without active Contribution

Example:

2013

International Congress Hidden Hunger 2013: From Assessment to Solutions. University of Hohenheim, Stuttgart, Germany, 6-9 March 2013 [Participation].

2014

Tropentag Conference 2014. Czech University of Life Sciences Prague, Czech Republic, 17-19 September 2014 [Participation].

Structure:

Header = The year in which the congress/conference/meeting took place;

Title of the congress/conference/meeting – Dot – Blank character – Location (institution/organisation, city and country) [each information separated by a comma followed by a blank character] – Date (day(s), month and year) – Blank character – **“Participation” in squared brackets** – Dot
